. Medication Overview

1.1 Composition and Formulation

Oxycodone is a semi-synthetic opioid derived from thebaine, an alkaloid found in the opium poppy. Commercial products contain oxycodone hydrochloride, which is formulated as immediate-release (IR) tablets, extended-release (ER) capsules, or oral solutions.
